Elevate for Homegrown Convention

A supplementary financial support to elevate the international participation through travel grant for paper presenters at the national homegrown events.

Meeting Size Requirement	Support Value	Support Items
Min 300 pax with 5% international paper presenters	From RM10,000 up to a maximum of RM20,000	Travel grant for international paper presenters

Criteria for Support:

1. The organisation applying for support must be registered with the Companies Commission of Malaysia or Registry of Societies of Malaysia.
2. Must be a paid event whereby registration fees must be collected from delegates.
3. Application must be received by Malaysia Convention & Exhibition Bureau (MyCEB) no later than 60 working days prior to the event date.
4. Must have a minimum of two (2) full event days.
5. Must comprise a minimum of 300 delegates, of which 5% are international paper presenters.
6. The travel grant is capped at RM350.00 per international paper presenter covering return economy flight and/or accommodation in Malaysia.
7. Applicant should achieve the targeted number of international paper presenters which is capped at 15% of the meeting size to receive full reimbursement of approved support value from MyCEB.
8. The support is applicable to new and existing homegrown events.

Terms & Conditions:

1. Financial support is claimable after completion of event with complete submission of documentation within the stipulated time.
2. This offer is not valid with any other MyCEB campaign or support.
3. Campaign is valid until 31 December 2024 and subject to approval and funding availability.
4. Provision of a "Request for Support Letter" from the corporate company, i.e. end user.

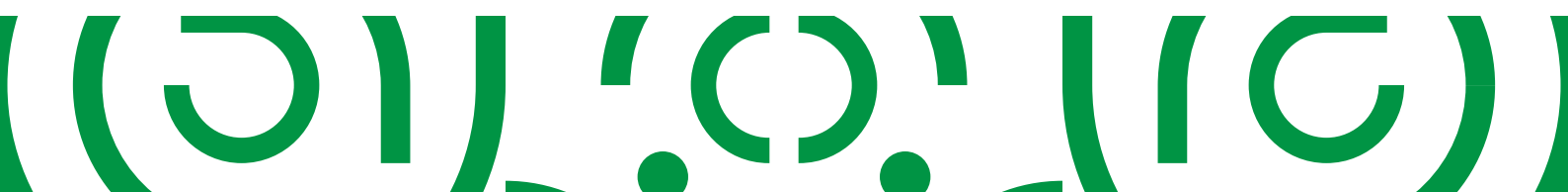
